Deposit of 50% is due at time of reservation. Remaining balance is due when you pick up your pet(s). There is a \$20 service charge on returned checks. We accept Checks, Visa, MC, Discover & Paypal. Deposits will be returned if a reservation is cancelled more than 72 hours prior to start date if visits fall on or within 3 days of a holiday, 24 hours for non-holidays. Deposits for reservations cancelled with less notice will be credited to your account to be used for future grooming or pet sitting service. Holidays are: New Year's Day, Easter, Memorial Day, 4th of July, Labor Day, Thanksgiving Day, Christmas Eve & Day & New Year's Eve.

Owner is responsible for all medical expenses/damages resulting from injury to pet sitter or other persons by the pet. Owner is responsible for any damages done by pet to pet-sitters home/property.

In the event that any animal(s) appears to be ill, injured or at a significant risk of experiencing a medical problem while in the care of Mobile Paw Spa, owner gives permission to seek veterinary care. Preferred veterinary services are listed with pet information. Other veterinarians or emergency care clinics chosen by Mobile Paw Spa are acceptable. All reasonable efforts will be made to contact owner in such situations, but if owner cannot be reached, the emergency contact person has the authority to make such decisions. Owner authorizes Mobile Paw Spa & primary veterinarian to share all medical records of all animals as needed in an emergency & in the interest of providing the best care. Owner will assume full responsibility for the payment &/or reimbursement for any & all veterinary services rendered & release Mobile Paw Spa & its pet sitters from any responsibility for the actions & decisions of the veterinary staff.

Owner must have legal rights to place the animals in the care of Mobile Paw Spa. If pets of separate owners are staying together, all owners must complete separate service contract & pet information sheets.

This contract permits Mobile Paw spa to accept all future reservations & provide service without additional signed agreements for current or any & all new pets acquired on or after the date this document was signed.

Mobile Paw Spa agrees to provide services in a manner that is trustworthy, caring & dependable. Owner relinquishes any & all claims against the company & its employees, except those arising from willful negligence
